- 1. This is an e-bid in which bids are being invited online and it is mandatory to submit Techno-Commercial Bid online at <a href="https://eproc.punjab.gov.in">https://eproc.punjab.gov.in</a> by specified date and time. Though bid document is also available on the website of the Punjab State Biotech Corporation (PSBC) i.e. <a href="http://www.pbtilabs.com/psbc/">http://www.pbtilabs.com/psbc/</a>, but that is just for information of prospective bidders. Online submission of bids through <a href="https://eproc.punjab.gov.in">https://eproc.punjab.gov.in</a> is mandatory. Bidder may search out the e-bid document on eproc.punjab portal on under Deptt. of Science, Technology & Environment and organisation, Punjab Biotechnology Incubator(PBTI).
- 2. Bidder must deposit Earnest Money Deposited (EMD) online as per mode specified in the website <a href="https://eproc.punjab.gov.in">https://eproc.punjab.gov.in</a>. EMD in any other mode will not be accepted by this office.

Secondary Agriculture Entrepreneurial Network (SAEN) is a multi —institutional networking project aimed to support industry and promote new start-ups in the Agri-food sector in Punjab. The project is being implemented by Punjab State Biotech Corporation with the support of Biotechnology Industry Research Assistance Council (BIRAC)-Department of Biotechnology, GoI.

- Online bids in the prescribed form are hereby invited on behalf of the Punjab State Biotech Corporation, Mohali for performing a Patent Landscape Study for F&V (Fruits and Vegetables) and C&G (Cereals and Grains) Processing sector.
- 2. The time allowed for the completion of the work is 04 (Four) weeks from the date of issue of Work order.

The technologies may be searched in the areas pertaining to Secondary Agriculture (processing, storage, novel products, nutraceuticals, shelf-life extension interventions etc.) excluding technologies related to pesticide, genetic engineering etc. Some keywords under areas are given below for reference.

**Processing** - Peeling, Size reduction, Destoning, Canning, Filtration, Oil Extraction, Concentration etc.

**Processed Products**- Fruit juices, Chips and fries, Canned products, Preserves, Pickles, Concentrates: sauce & puree, Alcohol beverage, Dried & Frozen products, Puffed products etc.

Storage- Refrigerated & Frozen etc.

**Novel products**- Lycopene oleoresin from tomatoes, Maize-germ oil high in unsaponifiable matter, Pasteurized fruit-based preparations produced using high-pressure treatment, Fermented soybean extract, Sugar cane fibre etc.
